

FISHING LOTTERY 2014 APPLICATION

To participate in lottery fishing from March 15, 2014 through August 15, 2014 on the White Lake property, applications must be completed and received in Room 422 of the Department of Wildlife and Fisheries Headquarters Building, located at 2000 Quail Drive in Baton Rouge by close of business February 20, 2014. Mailing address is: Department of Wildlife and Fisheries, Attention: White Lake Fishing, 2000 Quail Drive Room 422, Baton Rouge, Louisiana, 70808. Applicants must be 18 years of age or older. Individuals will be allowed to submit only one application. Submission of more than one application by any one individual will result in disqualification of the applicant.

A \$5.00 administrative fee will be charged for each application form submitted. Applications must be accompanied by a check or money order made payable to the Louisiana Department of Wildlife and Fisheries. This administrative fee is non-refundable. Applications must be legible and must have a correct driver's license number or they will not be processed.

This form is an application for fishing on the White Lake property. The area that can be fished will be the Florence Canal and Oil Field Location Canals off of the Florence Canal ONLY. Successful applicants will be provided a map of the fishing area. Strict adherence to the attached rules and regulations will be required. Successful applicants will be notified and required to submit an additional check or money order for \$40.00 to Louisiana Department of Wildlife & Fisheries. Check or money order must be received by close of business on the date specified in the winner's notification letter or applicant will be disqualified. Upon receipt of the check or money order, a permit will be authorized for the successful applicant.

RULES AND REGULATIONS
WHITE LAKE WETLANDS CONSERVATION AREA
March 15, 2014 – August 15, 2014
(SUNRISE TO SUNSET)

1. Fishing will be allowed in the Florence Canal and Oil Field Location Canals off of the Florence Canal ONLY.
2. There will be no fishing in any of the marsh areas or in the main Camp canal or other areas that are marked “NO FISHING”.
3. All boats will be limited to a maximum of 40 horsepower motor.
4. All “No Wake” signs must be obeyed.
5. Fishing must be done from boat only.
6. Rod and reel sport fishing only (no archery fishing, trot lines, jug lines, etc.).
7. Holder of the permit must be present (permit not transferrable).
8. There will be no boat launching from the White Lake properties. (Permittee must utilize public boat launch.)
9. Permit holder must have permit and boat decal.
10. Any violations of Louisiana boating or fishing regulations or any rule violations will result in immediate termination of permit.
11. Permittee will not be allowed to enter onto the White Lake WCA until sunrise and must exit the property by sunset.
12. No firearms allowed on premises.
