A \$5.00 administrative fee will be charged to each applicant. The administrative fee is NON-REFUNDABLE. Applications must be accompanied by a check or money order made payable to Louisiana Department of Wildlife and Fisheries (LDWF).

NOTE: LDWF WILL SEND EVERY SUCCESSFUL APPLICANT A GENERAL RULES LETTER AND MAP TO BUCKHORN WMA. EACH HUNTER WILL BE ASSIGNED TO A SPECIFIC STAND. STAND SELECTION WILL BE DETERMINED ON THE FIRST MORNING OF THE HUNT.

APPLICANTS MUST BE BETWEEN THE AGES OF 8 AND 17. EACH APPLICANT MUST PROVIDE AND BE ACCOMPANIED BY AN ADULT ESCORT AT LEAST 18 YEARS OF AGE. PLEASE CONSULT THE CURRENT HUNTING PAMPHLET FOR HUNTER SAFETY REQUIREMENTS.

A random computerized drawing will be held and successful applicants will be notified by mail. LOST OR MISPLACED PERMITS WILL NOT BE REISSUED. The permit is not transferable and must be in the hunter's possession while on the WMA during the hunt.
