To participate in the hunt, applications must be completed and returned to the above address, room 443 by close of business (4:30), **October 5, 2012**. No person may apply more than once. **SUBMISSION OF MORE THAN ONE APPLICATION SHALL DISQUALIFY THE APPLICANT.**

A \$5.00 administrative fee will be charged to each applicant. The administrative fee is **NON-REFUNDABLE**. Applications must be accompanied by a check or money order made payable to the Louisiana Department of Wildlife and Fisheries.

NOTE: EACH HUNTER WILL BE ASSIGNED TO A SPECIFIC STAND. STAND SELECTION WILL BE BY LOTTERY THE MORNING OF THE HUNT.

ALL APPLICANTS MUST BE BETWEEN THE AGES OF 8 AND 17. EACH APPLICANT MUST ARRANGE FOR AN ESCORT AT LEAST 18 YEARS OF AGE. PLEASE CONSULT CURRENT HUNTING PAMPHLET FOR HUNTER SAFETY REQUIREMENTS.

A random computer drawing will be held in late October and successful applicants will receive notification of hunt date and special hunt procedures by mail. **LOST OR MISPLACED PERMITS WILL NOT BE REISSUED.** The permit is not transferable and must be in the hunter's possession while on the WMA the day of the hunt.
