Youth Waterfowl Hunt to be held at the North Farm Waterfowl Area

To participate in one of these hunts listed below, applications must be completed and returned to the above address, room 442 by close of business (4:30), **October 05, 2012**. No person may apply more than once. **SUBMISSION OF MORE THAN ONE APPLICATION SHALL DISQUALIFY THE APPLICANT.**

A \$5.00 administrative fee will be charged to each applicant. The administrative fee is **NON-REFUNDABLE**. Applications must be accompanied by a check or money order made payable to Louisiana Department of Wildlife and Fisheries (LDWF).

NOTE: EACH HUNTER WILL BE ASSIGNED TO A SPECIFIC BLIND ON THE DAY OF THE HUNT.

ALL APPLICANTS MUST BE AT LEAST 10 YEARS OLD AND NO OLDER THAN 17 YEARS. EACH APPLICANT MUST ARRANGE FOR AN ESCORT AT LEAST 18 YEARS OF AGE. ALL APPLICANTS MUST POSSESS A HUNTER SAFETY CERTIFICATION OR PROOF OF SUCCESSFUL COMPLETION OF A HUNTER SAFETY COURSE. IF THE ACCOMPANYING ADULT IS IN POSSESSION OF A HUNTER SAFETY CERTIFICATION, A VALID HUNTING LICENSE OR PROOF OF SUCCESSFUL COMPLETION OF A HUNTER SAFETY COURSE, THIS REQUIREMENT IS WAIVED FOR THE YOUTH.

A random computer drawing will be held and successful applicants will be notified by mail. In the event the applicant is not able to participate on the date selected, the permit may be transferred to a qualified hunter of his choice. **LOST OR MISPLACED PERMITS WILL NOT BE REISSUED.** The permit must be in the hunter's possession while on the WMA the day of the hunt.
