Applications must be completed and returned to the address below or postmarked by **July 5<sup>th</sup>, 2015**.

**Only one of the three available lottery alligator harvest applications (CNR Division WMA, Wildlife Division WMA or Wildlife Division Public Lakes) may be submitted per person.**

Submission of additional applications will result in the subsequent disqualification of the applicant.

A random drawing will be completed by **August 2015**; successful applicants will be notified by mail.
