Applications must be completed and returned to the address below or postmarked by July 5th, 2015.
Only one of the three available lottery alligator harvest applications (CNR Division WMA, Wildlife Division WMA or Wildlife Division Public Lakes) may be submitted per person.

Submission of additional applications will result in the subsequent disqualification of the applicant.
 A random drawing will be completed by **August 2015**; successful applicants will be notified by mail.

A legal Louisiana resident.	A non-refundable administrative fee (\$5.00) will be charged to <u>ALL</u> applicants regardless of age.
At least sixteen (16) years of age.	Applications must be accompanied by either a <u>check</u> or <u>money order</u> made payable to <u>Louisiana Department of Wildlife and Fisheries</u> .
NOTE: Applications received with an incorrect social security number will not be processed.	NOTE: Applications received without the correct administrative fee will not be processed.

PURCHASE OF A RESIDENT ALLIGATOR HUNTING LICENSE (\$25.00) B.) **PAYMENT(S) OF \$40.00 (NON-REFUNDABLE) PER ALLIGATOR TAG IS DUE AT THE TIME OF TAG AND LICENSE ISSUANCE.** C.) SUBMISSION OF A HARVEST RECORD TO THE ISSUING OFFICE, LISTING CITES TAG NUMBER(S) AND CORRESPONDING LENGTH OF ALLIGATOR(S) HARVESTED WITHIN FIFTEEN (15) CALENDAR DAYS OF THE SEASON'S CONCLUSION D.) RETURN ALL UNUSED CITES TAGS TO THE ISSUING OFFICE WITHIN FIFTEEN (15) CALENDAR DAYS OF THE SEASON'S CONCLUSION.
