To participate in the hunt listed below, applications must be completed and returned to the above address, Room 442, by close of business (4:30) October 2, 2015. No person may apply more than once. **SUBMISSION OF MORE THAN ONE APPLICATION SHALL DISQUALIFY THE APPLICANT.**

The \$5.00 administrative fee will be charged to each applicant. The administrative fee is **NON-REFUNDABLE**. Applications must be accompanied by a check or money order made payable to Louisiana Department of Wildlife and Fisheries (LDWF). Applications must be submitted individually.

**NOTE: SELECTED APPLICANT WILL BE ASSIGNED TO A SPECIFIC BLIND ON THE DAY OF THE HUNT. LDWF PERSONNEL WILL ASSIST WITH ACCESSING THE BLIND, BUT THE SELECTED APPLICANT MUST HAVE AN ESCORT TO ASSIST WITH THE HUNT. THE HUNT DATE IS SATURDAY, DECEMBER 5, 2015.**

**ALL APPLICANTS MUST BE WHEELCHAIR-CONFINED, PHYSICALLY CHALLENGED HUNTERS PERMIT (PCHP) PERMITTEES. SELECTED APPLICANT MUST BE ACCOMPANIED BY ONE ESCORT. THIS INDIVIDUAL WILL NOT BE ALLOWED TO SHOOT. PLEASE CONSULT THE CURRENT HUNTING PAMPHLET FOR HUNTER SAFETY REQUIREMENTS.**

A random computer drawing will be held and successful applicants will be notified by mail. **LOST OR MISPLACED PERMITS WILL NOT BE REISSUED.** The permit is not refundable and must be in the hunter's possession while on the WMA the day of the hunt.
