

**2018 WMA TURKEY HUNT LOTTERY APPLICATION**

To participate in one of the WMA turkey hunts listed, applications must be completed and returned to the address below. Applications must be **received in the Baton Rouge office by 4:30 p.m. February 9, 2018**. Submission of more than one application shall disqualify the applicant.

A \$5.00 administrative fee will be charged to each applicant regardless of age. Applications must be accompanied by a check or money order made payable to the Louisiana Department of Wildlife and Fisheries. This administrative fee is non-refundable.

Applications may be submitted individually or as a group with no more than 5 applications per group. If applying as a group, each application must indicate the same choices, be stapled together and returned in one envelope. Applications submitted as a group will be drawn as a group. (Note: Only unsuccessful individual applicants will be awarded preference points. Unsuccessful group applicants will not receive preference points.)

A drawing will be held in early March and successful applicants will be notified by mail. The permit is non-transferable and must be in the hunter's possession while on the management area on the day of the hunt. **LOST OR MISPLACED PERMITS WILL NOT BE REISSUED.**
