To participate in one of these hunts listed below, applications must be completed and returned to the above address, Room 442 by close of business (4:30 pm) SEPTEMBER 28, 2018. APPLICANTS MUST BE 18 YEARS OF AGE OR OLDER. Hunters must submit a separate application form for each hunting date listed below and no person shall submit more than one application for any single hunting date or more than 3 applications for the season. SUBMISSION OF MORE THAN ONE APPLICATION PER HUNTING DATE OR 3 APPLICATIONS FOR THE SEASON SHALL DISQUALIFY THE APPLICANT.

A \$5.00 administrative fee will be charged for each application form submitted. Applications must be accompanied by a check or money order made payable to the Louisiana Department of Wildlife and Fisheries. This administrative fee is non-refundable. **ONLY THOSE WHO ARE SELECTED FOR A HUNT WILL BE CONTACTED.** 

This form is an application for a hunting area on the Sherburne South Farm Wetland Development Area. Each unit will accommodate a maximum of 3 people and a successful applicant will be allowed to bring no more than 2 guests. Successful applicants will be notified by mail and will be required to submit an additional check or money order for \$10.00 to the Department to participate in the hunt. Upon receipt of the \$10.00 payment, 3 permits will be mailed to the successful applicant.

A random computer drawing will be held and successful applicants will be notified by mail. **LOST OR MISPLACED PERMITS WILL NOT BE REISSUED. PERMITS ARE NON-TRANSFERABLE.** The permit is not refundable and must be in the hunter's possession while on the WMA the day of the hunt. No refund or rescheduled hunt will be provided in the event of cancellation of the hunt as a result of flooding or weather events.
