The Foundation is however obligated, in perpetuity, to monitor the status of the properties to assure they are maintained in the condition specified in the terms of the easement.

One of the properties and the related easement was transferred to the Louisiana Department of Wildlife and Fisheries in 2008 to be maintained as a wildlife management area leaving the Foundation with a total of 2,575 acres under supervision. The costs of this perpetual obligation cannot be reasonably estimated and no provision for this obligation is included in the accompanying statement of financial position. The owner of the remaining property has also pledged a total of \$175,000 to offset the Foundation's future costs of managing the easement. This unconditional promise to give has been recorded in the Foundation's financial statements."
