

LOUISIANA DEPARTMENT OF WILDLIFE AND FISHERIES
SCIENTIFIC COLLECTING PERMIT INFORMATION

- Permittee is limited to the personnel, purpose of collections, sampling areas, gear types and sampling techniques, and types and numbers of organisms to be collected, as indicated on the scientific collecting permit application. Any requested deviation will require Department approval.
- Permit will not exempt holder from any regulations imposed by other state, federal, parish or municipal agencies.
- The Department of Wildlife and Fisheries reserves the right to deny issuance of a scientific collecting permit to an individual who has been convicted of, or is awaiting disposition of, a citation involving a Class 2 wildlife and fisheries violation or greater.
- All permits shall expire on **December 31** of the year of issue unless otherwise noted. The Administrator may impose time limits and other restrictions on the duration of any collection permit.
- Sale of any organisms collected under the permit or their progeny, is prohibited.
- No item collected under the permit may be used for human consumption.
- One of the permittees must be in the company of the samples at all times. Permits are non-transferable but may be issued in more than one person's name. **A “Statement of Compliance” form must be signed by each individual to be listed on the permit.**
- Student requests will require **endorsement of professor**. Apply on official college or university stationery.
- If collections will occur on state Wildlife Management Areas, a separate **Wildlife Management Area Special Use Permit** is required. Similarly, if collections will occur on state Refuges, a separate **Letter of Permission** is required.
- Permit will not allow anyone to use chemicals, which are not approved for use in Louisiana by other state and federal agencies or exempt permit holder from any regulations by other state or federal agencies.
- Permittee is responsible for obtaining the proper applicator's licenses when using restricted use pesticides and other restricted use chemicals in aquatic sampling. The use of any chemicals must be fully described in the application.
- The appropriate regional law enforcement captain must be notified no later than 24 hours prior to sampling, with information including scientific collecting permit number, organization, name(s) of permittees, sampling area(s) and specific gear to be used.
- Any proposed use of **firearms, electrofishing gear or fish toxicants** require the written concurrence of the Enforcement Division as well as the Inland and/or Marine Fisheries Divisions. The appropriate regional law enforcement office must be notified prior to collecting. The permittee must provide date and estimated time of sampling, specific sampling areas, and routes to be taken to these areas. The district fisheries biologist will also be notified prior to sampling with electrofishing gear or fish toxicants. If you require the use of firearms at night, you must explicitly state this on the permit application. Mandatory background checks may add additional processing time to your permit.
- A scientific collecting permit application that includes the proposed usage of electrofishing gear or fish toxicants for use in public waters by a non-educational or non-governmental entity must be accompanied by a letter of support by an involved state or federal governmental agency.
- The use of explosives will normally not be permitted. Applicant must demonstrate to the Department's satisfaction that

no other effective means are available to collect aquatic organisms. Any proposed use of explosives requires the written concurrence of the Enforcement Division as well as the Inland and/or Marine Fisheries Divisions.

- Alligators are not permitted to be taken with the permit.
- A federal collecting permit is required to collect or possess any species covered by the Migratory Bird Treaty Act (List of Migratory Birds 50 CFR 10.13).
- Permits will not be issued for collection, including nonlethal collection, of any rare, threatened, or endangered species unless specifically approved (but see item below). If allowed to collect threatened or endangered species, you agree to provide the LDWF Natural Heritage Program with quarterly updates of those species collected.
- No S1 ranked species may be taken with the permit, except that:
 - One voucher specimen of these species or subspecies per site may be collected to document range extension or confirm the current occurrence of a species or subspecies suspected to have been extirpated at a site (i.e. not collected in the past 20 years); collecting more than one specimen shall require written approval justification submitted to and approved by the Louisiana Department of Wildlife and Fisheries, the approval number that being on the permit.
 - Any number of individual of these species or subspecies found dead may be salvaged.
 - Any number of individuals of these species or subspecies may be captured, processed (i.e. measured, marked, tissue samples taken by means deemed acceptable by the Louisiana Department of Wildlife and Fisheries, etc.) and released where originally found as part of a legitimate scientific study.
- An annual report giving a detailed description and inventory of all specimens collected is due within 60 days following expiration of permit. ***If no collections are made during a particular year, then a report should be submitted stating such.*** Permits are subject to cancellation if no report is received for prior year collections. Information to be included in annual report:
 - Name and permit number of the collector.
 - Name and location of each area, stream, or lake where collections were made. (All LNHP species encountered must be GPS'ed and reported with those coordinates.)
 - Date(s) of collection at each site or area.
 - Number and/or weight of each species taken (list by collection site or area and date of collection).
 - Method of collection.
 - Disposition of all animals taken.
- Permit holders shall contact the Enforcement Division of the Louisiana Department of Wildlife and Fisheries (Captain Cliff Comeaux 225-765-2980) in regards to disposition of these samples. If donated for official use a receipt will be issued. Enforcement Division may authorize other means of final disposition.

Statement of Compliance

I understand and agree that any permit issued to me by the Louisiana Department of Wildlife and Fisheries is in the nature of a privilege which is being voluntarily extended to me by the Department and the failure on my part to cooperate fully and completely with the Department or any of its employees can result in the loss of the privilege conferred and the denial of future requests for permits. By accepting a permit, I evidence my agreement to be bound by all conditions and stipulations set forth herein.
