

**FISHING LOTTERY 2018 APPLICATION**

To participate in lottery fishing on White Lake Wetlands Conservation Area property from March 15, 2018 through August 15, 2018, applications must be completed and received at the Department of Wildlife & Fisheries, 2000 Quail Drive, Room 418, Baton Rouge, LA 70808. All applications must be received by the deadline, close of business February 16, 2018, or they will not be processed.

Applicants must be 18 years of age or older. Individuals are only allowed to submit one application. Submission of more than one application by any one individual will result in disqualification of the applicant. A \$5.00 administrative fee, which is non-refundable, must accompany each application and must be in form of a check or money order (NO CASH ACCEPTED) made payable to the Louisiana Department of Wildlife and Fisheries (LDWF). **Please note on the payment the applicants name and that the payment is for the 2018 Fishing Lottery.** (Ex. John Doe - 2018 Fishing Lottery)

Successful applicants will be notified via mail and are required to submit an additional payment of \$40.00 for their fishing permit to the Louisiana Department of Wildlife & Fisheries by the deadline provided in the award letter, or the applicant forfeits their permit.

Strict adherence to the attached rules and regulations will be required.

**RULES AND REGULATIONS**  
**WHITE LAKE WETLANDS CONSERVATION AREA**  
**March 15, 2018 – August 15, 2018**  
**(SUNRISE TO SUNSET)**

1. Fishing will be allowed in the Florence Canal and Oil Field Location Canals off of the Florence Canal ONLY. (Successful applicants will be provided a map of the fishing area.)
2. There will be no fishing in any of the marsh areas or in the main Camp canal or other areas that are marked “NO FISHING”.
3. All boats will be limited to a maximum of 40 horsepower motor.
4. All “No Wake” signs must be obeyed.
5. Fishing must be done from boat only.
6. Rod and reel sport fishing only (no archery fishing, trot lines, jug lines, etc.).
7. Holder of the permit must be present (permit not transferrable).
8. There will be no boat launching from the White Lake properties. (Permittee must utilize public boat launch.)
9. Permit holder must have permit and boat decal.
10. Any violations of Louisiana boating or fishing regulations or any rule violations will result in immediate termination of permit.
11. Permittee will not be allowed to enter onto the White Lake WCA until sunrise and must exit the property by sunset.
12. No firearms allowed on premises.
