General information

Registration is separate from titling. A title does not replace registration. A title provides ownership, and is required to secure ownership interest when a boat is financed. **A copy of this signed and dated application can be used as a temporary registration for 60 days.** If your documents are not received within 60 days, please notify the office at (225) 765-2898.

All registration/title requests require:

- Completed boat application
- Documentation demonstrating chain of ownership to the applicant
- Applicable documents below

Failure to supply all information including signature of owner will result in delayed processing or denial of your application.

Newly purchased boat/motor

Boats from Out of State

- **Purchased from an individual:** Submit bill of sale, out-of-state title and/or registration, and a [Tax Payment Certification Form](#) (R-1331) from LA Dept. of Revenue
- **Dealership (titled/registered):** Submit dealership invoice or bill of sale, out-of-state title and/or registration, proof of ownership from previous titled/registered owner to the dealership, and a [Tax Payment Certification Form](#) (R-1331) from LA Dept. of Revenue.

Purchased from Louisiana Dealership

- Original Manufacturer's Statement of Origin (MSO)
- Copy of invoice from dealership
- Proof of Louisiana state and local taxes on the invoice, OR a completed [Tax Payment Certification Form](#) (R-1331) from Louisiana Department of Revenue


Transfer of ownership

- Bill of Sale including LA registration number, HIN, and signature(s) of seller(s) and purchaser(s)
- If previously titled or the title is held by a lien-holder, the title must be surrendered at the time of registration.
- If owner is deceased
 - Judgment of Possession awarding the boat to heir(s), OR
 - If no succession, [Affidavit for Transfer of Decedent's Boat](#) and a copy of the death certificate
- If boat is sold by the decedent heir(s), a bill of sale from the heir(s) is required

Inspections

First time boat registration in Louisiana without a HIN or an incorrect HIN must be inspected and titled.

- [Inspection application](#) (in addition to the Boat application)
- Original receipts for materials including Louisiana taxes must be provided at the time of inspection.
- Homemade boats: an inspection must be scheduled with your LDWF regional office after application is processed.
