



LDWF Profile Completion Checklist

Business Information*

**All applicants will be required to complete the Business Information section of the Applicant Profile.*

- Applicant Name
 - Enter the First Name, Last Name and Suffix (if applicable) as provided on your Louisiana Department of Wildlife and Fisheries (LDWF) resident commercial fisherman’s license, vessel license, charter license, or wholesale retail dealer license for which you will be applying under.

- Applicant SSN
 - Enter the Social Security Number (SSN) of the individual associated with your LDWF license and listed as “**Applicant Name**” above.

- Applicant Business Name
 - If applying under a Charter license or Commercial Fisherman license, enter the Full Legal Name of the individual associated with the LDWF license.

 - If applying under a Vessel license or Wholesale Retail Dealer license, provide the Legal Business Name registered with your LDWF license, if applicable, otherwise, provide the Full Legal Name of the individual associated with the LDWF license

- Applicant Business SSN or FEIN
 - Provide the SSN or FEIN for the individual or business entity reported in “**Applicant Business Name**” above.
 - If “**Applicant Business Name**” is reported as the First and Last Name of the individual associated with the LDWF License, please provide the SSN for this individual.

 - If “**Applicant Business Name**” is reported as the Legal Business Name registered with your LDWF license, please provide the FEIN registered to this business entity.

- Applicant Business TIN Type
 - Applicants must select one of the following aligning with the type of TIN entered in “**Applicant Business SSN or FEIN**” above:
 - SSN
 - FEIN

- Applicants must select one of the following business types:
 - Individual / Sole Proprietorship
 - LLC
 - Partnership
 - Corporation
- For LLC, Partnership and Corporation business entity types, please note that a Board Resolution Form will be required to be submitted at a later date within your application.

Louisiana Secretary of State Charter Number (See Guidance on Pg. 4 below)

- Enter the LA SOS Charter # associated with the Applicant Business's LDWF license, if applicable.
 - **Please note that Applicant Businesses registered with the LA SOS must be "In Good Standing" with the Louisiana Secretary of State (SOS) to be eligible for the Program.**
- Individuals or Sole Proprietorships who are not legally required to register with the Louisiana SOS **will not be required** to provide an LA SOS Charter #. Instead, these Applicants should enter N/A.

Business Physical Location Address

- Enter the physical address where the Applicant Business or Vessel is located.
- For Applicants without a distinct business location address, please enter the physical home address of the individual associated with the LDWF resident license.

Business Mailing Address (if different from Physical Location Address)

- Please note the Business Mailing Address will be used by the Program for the mailing of any grant award checks to the Applicant Business. Please ensure you are actively receiving mail at this address.
